Highlight:

As the fiscal year-end for 2024-25 draws near, accountants are diligently preparing and finalizing financial reports. In anticipation of this crucial period, the Hong Kong Institute of Certified Public Accountants (HKICPA) released a timely publication titled 'Financial Reporting Considerations for Closing Out 2024' in February 2025.
