The latest amendments to the Hong Kong Financial Reporting Standards (HKFRS) for Private Entities, issued in April 2025, represent comprehensive enhancements that closely mirror the third edition of the IFRS for SMEs from the IASB. Effective from 1 January 2027, these modifications seek to simplify financial reporting for private entities while preserving essential transparency and relevance.
